Investigation Description: On April 12, 2023, I, Molly Goodman – Solid Waste Specialist, initiated a complaint investigation regarding concerns of odors coming from a livestock composting facility, Kingdom Provisions, located at 5960 Durham Road, Pipersville PA 18947. The complainant was available to chat over a phone call with additional details about the situation. They elaborated that the odors had begun a few months ago after the property transferred owners. The facility had been accepting multiple large trucks containing cattle on a daily basis. They alleged that Kingdom Provisions has been burying the remains of the carcasses on the site and turkey vultures had been circling the area. Plumstead Township has been contacted, and the complainant stated that in response, Kingdom Provisions had accepted approximately forty (40) loads of soils, which had been applied on top of the area they had seen remains being buried. The complainant stated that the Pennsylvania Department of Agriculture ("DOA") was also contacted.

Investigation Description: On April 18, 2023, an onsite investigation was conducted. Jesse Hill, Zoning Officer for Plumstead Township, and Melanie Biason, Environmental Protection Specialist for the Bucks County Department of Health, were additionally in attendance. Ephriam Stoltzfus, Owner of Kingdom Provisions, was available to provide access to the site and discuss concerns regarding the facility. Mr. Stoltzfus stated the facility is regulated by the USDA and that the property was currently being leased, with a plan to fully purchase the area in December 2023. Mr. Stoltzfus stated no dead animals are accepted and the slaughter operation follows strict guidelines in the presence USDA representative. The facility accepts and slaughters lambs, sheep and cattle and takes in approximately 200-250 animals per week in about 2 loads. The livestock mortality composting occurs in the back of the property, on a concrete pad to prevent leaching into groundwater supplies. Mr. Stoltzfus explained that the process involves a base layer of about 5-6" of a mixture of manure from the site and wood waste/shavings from Heacock Lumber. Livestock waste is placed on top of the mixture and an additional layer of the wood/manure mixture is used as cover. Mr. Stoltzfus stated that the vultures and odor had occurred during a period when the compost was not being regularly turned. Currently, the facility is turning compost on a regular basis, monitored for temperature, and Mr. Stoltzfus is requiring employees to provide photographic evidence that the piles are being covered at night. An odor was detected when standing at the location of the compost piles, but standing approximately 50 feet downwind, there was a faint odor that would be that of a typical operation.

Investigation Description: On June 6, 2023, I, Molly Goodman – Solid Waste Specialist, conducted a complaint investigation regarding odors alleged to be coming from Kingdom Provisions, located at 5960 Durham Road Pipersville PA 18947. Paul Jardel, Water Quality Specialist, was additionally in attendance. Complaints received by the Department allege that odors smelling like sewage and rotting flesh have been affecting the nearby neighborhood and expressed concerns that run off from the site could be entering a nearby stream or potentially contaminating well water.

Following the investigation into this complaint on 5/11/2023, the Department has requested that Kingdom Provision demonstrate how the composting of waste generated by their process follows best management practices ("BMP"). Kingdom Provisions has been provided the Food Processing Residual ("FPR") manual, to assist in establishing their BMP. Kingdom Provisions has responded to the request by stating that Tri County Spreading has been contracted to develop a Nutrient Management Plan Agricultural Erosion & Sedimentation Plan, and a Compost Operations Plan that includes an Odor Control Plan. Tri County Spreading is expected to complete this information for Kingdom Provisions before June 15, 2023.

At the time of this inspection, Kerry Rush, Owner/Operator, was at the site and was able to discuss the operation and current conditions of the property. Mr. Rush stated that the piles of waste are not being composted and are storage piles. If the waste is not composted following BMP, Kingdom Provisions is obligated to manage the material as a residual waste. At the time of the inspection Kingdom Provisions had failed to properly manage residual waste as described at 25 Pa Code section 299.101. Kingdom Provisions failure to properly manage residual waste without a first obtaining a permit is a violation of 25 Pa code section 287.101(a).All putrescible waste should be removed immediately and residual waste generator requirements should be enacted.

A site walk was conducted. Behind the slaughterhouse, a hole approximately 6" in diameter was observed to be uncovered. Mr. Rush explained it was a drain for the sewage tank, and that when the operations were occurring, the hole becomes blocked as a result of the machinery moving and covering the drain. Mr. Rush stated that human waste deposited to the septic system is completely segregated from animal waste, which is used for composting. A tank used to store waste blood from the slaughtering process was explained to be pumped out regularly for disposal. Mr. Rush was unable to provide receipts for the collection and disposal at the time of the inspection.

The compost pile appeared to be covered and was observed to be completely confined to the concrete pad. Mr. Rush stated that animal remains are layered with a mixture of animal waste and saw dust/wood that is received from Heacock Lumber. Based on a visual inspection, it appeared that no other materials have been mixed in or added to the compost.

No odors were detected along the road in front of the property. Mr. Rush stated that Kingdom Provisions was aware that odors were present and that odors from their business have been strong in the past few days. He attributed the odors to the weather conditions, being hot and humid. It was noted that it is early June 2023 and it is unacceptable to allow odors to persist, travel off site and cause a public nuisance.

Mr. Rush additionally suggested the odor is coming from a container located behind the slaughterhouse. Noticeably strong odors of decaying animal remains were detected within approximately 20' of the container. Mr. Rush stated that the container was used for waste bones and fat. Primarily cardboard and remains of slaughtered animals were observed in the container and debris, including parts of an animal carcass, was observed outside the container. Upon closer inspection, the container was observed to harborage a large number of vectors. Kingdom Provisions stored putrescible waste in a manner that failed to minimize and control conditions that create a public nuisance, contrary to 25 PA Code 299.115. Mr. Rush stated that the waste will be removed from the site in a timely manner and documentation will be provided that will demonstrate the waste has been disposed of properly.

The owners of Kingdom Provisions have reach out to the Department to discuss following best management practices or containerizing and disposing of their waste. Further compliance of this operation will be tracked through efacts site ID: 8658337

Complaints about foul smells have been an on-going issue and site visits were conducted previously on April 18, 2023, and June 6, 2023. The initial inspection on April 18 was conducted with Plumstead Township and Bucks County Department of Health and at that time, the odors detected at the site were typical for an operation with livestock and no vector species were observed. Ephraim Stoltzfus, Owner/Operator, was at the site at the time of the inspection and acknowledged Kingdom Provisions had failed to maintain their composting pile a few weeks prior, which had attracted turkey vultures to the site. On May 11,2023, Mr. Stoltzfus was contacted via email and was provided with a copy of the Food Processing Residual Management Manual and was requested to submit a Nutrient Management Plan and an Agricultural Erosion and Sedimentation Plan in accordance with the Food Processing Residual Management Plan. The facility contracted Tri County Spreading to develop and provide the documents by June 9, 2023. On June 6, 2023, strong odors of decaying animal remains were detected at the site and an uncovered container with waste bones and fat was observed to be harboring a large quantity of flies. Kingdom Provisions was cited for violations for failing to store putrescible waste in a container that is sealed, watertight, leakproof, insect-proof and rodent-proof contrary to 25 PA Code 299.121(c) and not minimizing and controlling conditions that create a public nuisance, contrary to 25 PA Code 299.115(a) and (b). An inspection was conducted on July 6, 2023 in conjunction with Jennifer Ramos-Buschmann, Air Quality Specialist, and William Laufer, Environmental Trainee, from the Department's Air Quality Program. At the time of the inspection, Kingdom Provisions had not corrected the violations and have not submitted the requested documents. Amber and Brent Pressley were available to provide a walkthrough of the site and discuss the current state of operations. The facility had a large increase in lambs being slaughtered on June 27, 28, and 29 as demand increased for the Eid al-Adha holiday, although Mrs. Pressley was unsure the quantity of lambs slaughtered at that time. Mr. Pressley stated that the facility is now disposing of residual products from the operation, which is removed from the site by Darling Rendering on Tuesdays and Fridays. The facility is continuing to add additional material to the compost pad when the quantity generated exceeds the capacity that will be removed by Darling Rendering. Mrs. Pressley stated that Darling Rendering will not accept the skins, which are currently being removed by Republic with regular waste pickup and are stored in the dumpster. Upon entering the site, a strong odor of decaying animal remains was detected. The composting area contained a layer of exposed animal entrails and Mrs. Pressley stated that the compost is turned and covered. The facility was reminded to immediately cover the material after adding to the pile. A container and cardboard box were observed adjacent to the compost pile and contained open plastic bags of what appeared to be old meat. A large quantity of vectors was observed, and the facility was reminded to properly containerize food processing residual wastes. An additional container was observed to have a dark sludge from the decomposition of skins and bones. Mrs. Pressley stated that she would remove the material immediately and request new, clean containers from Darling Rendering. Mrs. Pressley stated that she will send the Department a copy of a receipt or other evidence that the material has been removed from the site. The dumpster at the site was observed to be approximately half-way full of a conglomerate of skin, bones, and nonanimal biproducts of the residual waste operation. The dumpster appeared to be leaking fluids and the facility was actively covering the affected areas of the ground. The facility was reminded to properly containerize waste materials in a manner that prevents leaks or other releases. Additionally, the facility was requested to submit to the Department a copy of a disposal receipt. The conditions observed at the time of this inspection, demonstrates noncompliant residual waste storage practices as well as the mismanagement of waste in compost piles. Kingdom Provisions has not been implementing BMPS for the use and management of the food processing waste generated on-site. By failing to implement best management practices ("BMPs"), the regulations do not provide Kingdom Provisions the permit exemption. Kingdom Provision's operation of a residual waste processing and disposal facility without first obtaining a permit is contrary to 25 Pa. Code Section 287.101(a). Investigation Description: On August 17, 2023, I, Molly Goodman, Solid Waste Specialist, conducted a follow up inspection of Kingdom Provisions, located at 5960 Durham Road, Pipersville PA 18947. Jonathan Bower, Solid Waste Supervisor, Jenifer Ramos-Buschmann, Air Quality Specialist, and Gina Thomas, Attorney, were additionally in attendance. Angela Benner, Plumstead Township Manager, Steve Hicks, Land Use & Planning Administrator, Phil Neas, Building Inspector, and Will Oetinger, Esquire, were able to meet to discuss recent violations issued by Plumstead Township and attend the site visit. During a meeting with Plumstead Township prior to the site inspection, their concerns about the potential for contamination of well water and odors from the site were discussed. Additionally, Plumstead Township explained that they had been notified that Kingdom Provisions was allegedly excavating and burying animal remains at the site, as well as continuing operations despite their cease and desist order. Kerry Rush, Owner, and John McShea, Attorney, were available at the site to provide a tour and discuss the current operations. Faint odors, that would be typical of farming operation with livestock, were detected at the site. Live animals were observed at the site and Kingdom Provisions was not actively engaging in the slaughtering operation. Kingdom Provisions currently has contracts with MOPAC to remove residual product for rendering and Republic to provide and empty the dumpster onsite. MOPAC is scheduled to pick up material three (3) times per week and Republic removes waste from the dumpster two (2) times per week. Kingdom Provisions is working to have pickups available to remove material on days when larger quantities of animals are slaughtered and/or when high temperatures create odors and other nuisances. Containers were observed behind the slaughter building that had a noticeably stronger odor of decomposition. Mr. Rush stated that the facility is no longer singeing the hair off animals slaughtered at the property. At the time of the inspection, waste was confined to storage containers. These bins were in proper condition, covered, and there was a noticeable decrease in the number of flies near the containers. The dumpster at the property has been replaced by a container that is closed on the sides and the lid was observed to be closed. Putrescible waste at the site was properly contained and managed in a manner that controls nuisances and it was determined at this time that Kingdom Provisions is no longer in violation of 25 PA Code 299.121(c) and 25 PA Code 299.115 (a) and (b).

The concrete storage pad was no longer being used for food processing residual composting. The material on the pad that had not been fully processed was removed from the site for disposal. Kerry Rush stated that most of the composted material was taken offsite for land application on another farm. The area adjacent to the concrete pad where the compost pile had been located was recently regraded. It appeared that compost had been used in this area. Some odors and litter were observed as well as some ponding of stormwater(Image 6).Kingdom Provisions was reminded to properly manage stormwater throughout the site. Composting operations are no longer conducted at the site and it was determined at this time that Kingdom Provisions is no longer in violation of 25 PA Code 287.101(a).

We met with Brent Pressley who showed us to the back of the facility where the compost pile and dumpster are located. We noted objectionable odors in these areas. The odors seemed isolated to those areas and did not appear to cross the nearest property lines. Mr. Pressley stated that the odors are strongest on the days that Valley Protein comes to pick up rendering wastes, which are typically Tuesdays and Fridays. We then met with Molly Goodman, DEP Waste Program, and Amber Pressley. Ms. Goodman and I requested that the dumpster, the rendering bins, and the compost pile be covered at all times; all of them were open/uncovered during the inspection, the compost pile was partially covered. Ms. Goodman and I will follow-up regarding these requests. Upon arrival on site, winds were SE at 5 mph and it was 89°F and mostly sunny/partly cloudy. On 7/11/23, I spoke with one of the complainants regarding the findings of my investigation. They also indicated that they were smelling the odors again today and were going to file another complaint. On 7/12/23, Alec Yarnell, Margaret Thompson, Ashely Davis, and I arrived onsite at 3:25 PM to conduct an odor complaint inspection. We met with Brent Pressley briefly. Prior to arriving onsite, we conducted odor surveillance along Durham Rd. and noted burning and rendering type odors which we determined to be objectionable. Mr. Pressley asked us to leave the property. After leaving the facility, we then conducted additional odor surveillance along Durham Rd. and continued to smell the odors offsite. We then returned to the facility at 3:55 PM at Mr. Pressley's invitation. At the time of inspection, winds were WSW at 6 mph and it was 87°F and sunny. On 7/31/23, Molly Goodman and I arrived on site at 12:00 PM to conduct an odor complaint inspection. Prior to arriving on site, I noted fleeting rendering type odors along Durham Road. The odors were strong at times. We then met with Amber Pressley who showed us to the compost pile and rendering bin storage area. We noted open and partially open closed rendering bins filled with animal remains/skins, animal remains on the ground near the bins, and animal remains/bones in the bin of a front-end loader. Ms. Pressley stated that the lids were previously closed, but the inner organs expand in the heat and caused the lids to open. Ms. Pressley also stated that a newer employee had probably filled the bins too high and she would tell them to not fill the bins too high so that they can be properly closed. Ms. Pressley stated that Mopac now comes on Mondays, Wednesdays, and Fridays to pick up the remains. I observed a Mopac truck pickup the remains in the bins around 2:00 PM- 2:25 PM. Ms. Pressley stated that only the animal hides are currently being added to the compost pile. I recommended they try to find another way to dispose of the hides because they may be contributing to the odors. I noted the rendering type odors near the compost pile and the rendering bin area. I noted a burn barrel and cardboard boxes near the rendering bin area. Ms. Pressley stated that they burn cardboard that can't be used for packaging meat. I informed her of the open burning regulation and requested that they cease open burning going forward. During my 7/12/23 inspection, I noted smoke coming from the facility's vents and something smoldering on the ground. Ms. Pressley stated that they sometimes burn the hair off animal carcasses before selling them, which is what causes the smoke, and the smoldering could have been from burning carboard boxes. Ms. Pressley stated that they may be considering purchasing an incinerator to dispose of unwanted animal remains. I explained that they would likely need an air guality permit to operate an incinerator and I would email her more information on how to obtain a permit should they choose to do so. The compost pile was covered at the time of inspection except for a whole cow carcass which was not fully covered. Ms. Pressley stated that it was previously covered, but it expanded/became bloated in the heat which caused it to become uncovered. Ms. Goodman and I requested that it be covered. During my 7/6/23 inspection, Brent Pressley stated that 300-400 animals are slaughtered at the facility a week, that some animals are purchased from auctions, and most of their customers are from NY and NJ states. Ms. Pressley was unsure how many animals were received so far this week. Ms. Pressley stated that she had not been notified by Plumstead Township to remove their compost pile in 30 days. Ms. Goodman and I will reach out to the township regarding this matter. At the time of inspection, winds were NW at 4 mph and it was 81°F and sunny.

On 8/2/23, I emailed my three field inspection reports from 7/6/23, 7/23/23, and 7/31/23 to the first complainant.

Investigation Description: On 9/21/23, I conducted odor surveillance along the neighboring roads near Kingdom Provisions prior to the site inspection and did not note any objectionable odors.

On 9/21/23, Molly Goodman and I arrived on site at 10:50 AM to conduct a complaint inspection. We met with Kerry Rush who showed us around primarily outside the facility. Mr. Rush showed us the part of the building that had been used for singeing animal carcasses. I noted a propane tank that had a torch on top of it. Mr. Rush stated that the tank is now connected to a water tub in an adjacent room and is used to heat the water so that the carcasses are boiled in order to remove the hair instead of burning the hair off. Mr. Rush stated that they no longer singe the carcasses but was unsure of when exactly they stopped. We then walked to the trash bin area and I observed a Republic bin and a new Waste Management bin. Mr. Rush said that they are no longer using Republic because they (Republic) said the bin was too heavy to pick up. So they are now using Waste Management, but Mr. Rush was not sure how often they come to empty the bin. Mr. Rush stated that Waste Management picks up the sheep skins, and the cow hides are now salted and sold to someone who comes once a week to pick them up. I observed the salted hides are stored in a trailer; I did not note odors coming from that trailer. I noted rendering type odors near the trash bins and the empty and full rendering bins; the odors appeared to be present only within those immediate areas (at that time). I observed four full rendering bins that were covered in plastic and several empty rendering bins that had fat and other remains partially stuck to them. There was also some liquid residue on the ground near the bins. Mr. Rush stated that the dirty rendering bins would be cleaned today, and I observed some other waste bins being washed while I was on site. Mr. Rush said that Mopac came and picked up bins on Monday 9/18/23 and Wednesday 9/20/23, but they left behind four bins on 9/20/23, because their truck was full, which caused odors. Mr. Rush said they are in the process of obtaining a refrigerated "c box" trailer to store the rendering bins going forward, but they need to get a permit first and then they will order the trailer; he hopes to get the trailer in the next few months. Mr. Rush stated that they slaughter 10-20 cows a week on Tuesdays and about 200 sheep a week, and Mopac still comes on Mondays, Wednesdays, and Fridays. We then observed the former compost pile area and there appeared to be no new material added. There was some standing water on top of the small pile that remains, and I noted a faint odor in that area. I noted minor/fleeting rendering odors in the facility's driveway that appeared to be carried by the wind. I reminded Mr. Rush that burning/singeing the carcasses is not permitted without a control device being installed. Mr. Rush stated that he was not aware of any issues with the facility's sewage system.

On 9/21/23, I spoke with the complainant and informed them of the findings of my investigation. The complainant stated that they spoke with the owner of the property, Nick Lykon, on 9/16/23 who stopped by the facility that day and he observed that the facility personnel were singeing animal carcasses and he told them to immediately stop and to stop burning the carcasses going forward. The complainant stated that they have not noted burning odors since then, but still occasionally smell decomposing animal odors, and the sewage odors seem to occur once a week. They told me that the odor issues have seemed to improve, but they would continue to file complaints if the odors continue. I told them I would continue to follow-up with them with any new updates regarding the facility.

Investigation Description: On September 21, 2023, I, Molly Goodman -- Solid Waste Specialist, completed an onsite complaint investigation regarding odors at Kingdom Provisions, located at 5960 Durham Road, Pipersville PA 18945. Jennifer Ramos-Buschmann, Air Quality Specialist, was additionally in attendance. The site has been investigated following numerous complaints and the cited violations were marked resolved on August 17, 2023. Kerry Rush, Owner, was at the site and available to provide access and speak about recent conditions. The decomposition odor was really only noticeable when the wind blew and within a few feet of the containers with remains. Mr. Rush said that MOPAC had come yesterday (9/20/2023) to collect leftover animal carcasses, but they did not have room on their truck so they left four (4) containers behind, which were covered with plastic bags and liquid was observed seeping out and pooling on the ground. We spoke about secondary containment and/or lining the containers with the plastic bags. Mr. Rush said that Republic was not taking the remains that MOPAC will not take, so they started a new contract with WM and an 8-yard container was observed at the site in good condition. The skins of the cows are being treated with salt and sold as product. There was a bit of fat and discarded remains scattered around the site and we spoke about cleaning up throughout the day instead of one cleanup at the end of the day. Kingdom Provisions is no longer composting onsite and all composted material was pushed past the edge of the concrete pad. Investigation Description: On 10/12/23, I conducted odor surveillance along the neighboring roads near Kingdom Provisions prior to the site inspection and did not note any objectionable odors.

On 10/12/23, Molly Goodman (DEP Waste Program) and I arrived on site at 2:00 PM to conduct a complaint inspection. We met with Kerry Rush who showed us to the rendering bin storage area and the dumpster area. I noted a strong rendering/decomposing type of odor in those areas that appeared to be present only within those areas. Winds were W at 3 mph at the time of inspection, and it was sunny and 70°F. A couple rendering bins were uncovered and full and/or had not been rinsed out. Mr. Rush instructed workers to cover the bins with plastic and lids, which they did. Mr. Rush stated that they are waiting to get new bins which have a tighter seal to better control the odors, however the bins are on back order. Ms. Goodman and I also recommended covering the top of the dumpster with plastic since it doesn't have a tight seal either. The dumpster lid and side doors were closed. I noted a few animal remains/fat on the ground near the bins and dumpster, and Mr. Rush said they would be immediately cleaned up going forward. I noted that the salted hide trailer was moved closer to the building and the remains that were near the previous location had been removed. The former compost area appeared more level and I noted very little standing water. Mr. Rush stated that Mopac still comes to pick up rendering bins on Mondays, Wednesday, and Fridays, and Waste Management comes to empty the dumpster on Tuesdays and Thursdays. Mr. Rush stated that Mopac has been picking up all the rendering bins recently and if they don't, the rendering could be disposed of in the Waste Management dumpster, I observed Waste Management empty the dumpster at 3:08 PM, and I noted rendering/decomposing odors in the facility's driveway at that time. Mr. Rush stated that they are still not burning/singeing animal carcasses/hair and they are still planning to purchase a refrigerated trailer. I observed a truck come to empty an underground tank that stores wastewater and blood from the facility, which did not appear to cause odors.

On 10/17/23, I conducted odor surveillance along Durham Road in between Stump Road and Kingdom Provisions around 3:00 PM and I noted rendering/decomposing odors which I determined to be objectionable. I called Kerry Rush prior to walking along Durham Road and he stated that he was no longer on site and there was no one on site to meet with me. I met with one of the complainants at their residence around 3:30 PM and I noted the same objectionable odors at their property. Winds were WNW at 4 mph and it was cloudy and 59°F at that time. The odors appeared to consistently come and go with the wind and would linger for about 5-15 minutes at a time. I noted the odors again at 3:56 PM, 4:07 PM, and 4:22 PM before I left the complainant's property. I told the complainant I planned to visit the site again next week and I would follow-up with them regarding my findings. I also told them that I would inform Angela Benner, Township Manager of Plumstead Township, of my investigation findings.

On 10/25/23, I spoke with the complainant who initially indicated that the decomposing odors were not noted today, but they were bad the previous two days. I told them that I was near Kingdom Provisions and I was going to stop by soon. At the end of the phone call, the complainant stated that they began noting faint decomposing odors.

On 10/25/23, I arrived on site at 2:17 PM to conduct a complaint inspection. Upon arriving, I noted faint decomposing odors in the facility driveway. Winds were SW at 6 mph and it was 71°F and sunny. I met with Kerry Rush who showed me to the rendering bin storage area and dumpster area. I noted that all but one bin was covered and the lids do not make a tight seal. I also noted several smaller trash bins filled with animal skins that were not covered. Mr. Rush stated that the skins were going to be placed in the dumpster shortly and MOPAC would be there within the hour to empty the rendering bins. The dumpster contained animal heads and other remains. The lid was open and then Mr. Rush closed it; the lid does not make a tight seal. I noted strong decomposing odors in this area. Mr. Rush said that he is going to build a temporary enclosed holding area for the bins until they purchase the refrigerated trailer. Mr. Rush also said he would email me receipts for the new rendering bins that were purchased but are on back order. I noted the decomposing odors in the facility driveway prior to leaving the facility.

On 10/25/23, I conducted odor surveillance along Durham Road near Kingdom Provisions after the site inspection and did not note any objectionable odors.

When asking why we never smelled anything when the Gouldey's were the owners, he said the Gouldey's processed 10 animals a week, but he processes 200 a week. In December of 2023, Plumstead Acquisitions contacted us tha previous renter Kingdom Provisions had purchased the property and was the new owner. The stin became worse again in December and into January. Early January there were times when it was quite horrible. We were away for a few weeks. In mid-February the stench became worse. On February 12th it was truly horrible and the worst it had been in a while.

I noted slight rendering odors next to the rendering bins, some of which were not fully closed/sealed. Ms. Pressley said they were being picked up/taken off site today. I requested that the bins be completely closed/covered going forward. The odors appeared to only be present in that immediate area. We then walked to the fields where the FPR (Food Processing Residual: mineral/wash water/blood) is spread and tilled deeply into the ground. I noted no odors in the field area. Mr. Pressley said that MOPAC is currently down and not picking up rendering waste until Monday (3/18/24), so he is taking the rendering waste offsite to be composted/disposed of elsewhere in Lancaster, which they regularly do on Tuesdays and Thursdays since MOPAC normally comes on Mondays, Wednesdays, and Fridays. I will touch base with the DEP Waste Program regarding spreading the FPR in the three fields. The dumpsters were moved to the front of the property since they only put regular trash (no hides) in them now. Winds were WSW at 7 mph and it was 69°F and mostly sunny at the time of inspection.

We then walked to the back of the facility and I noted slight decomposing odors. Mr. Stoltzfus stated that the odor was due to blood/body fluids that dripped from a trailer that was parked there earlier; he then had a worker scrap up the soiled area and remove it. We then walked to a field in the back left of the property where the new compost pile is. Mr. Stoltzfus stated they began composting this past Wednesday (4/24/24). I noted a slight decomposing odor near the pile and Mr. Stoltzfus instructed a worker to cover certain exposed areas and skins with 12 inches of wood chips which he said will help contain odors. Mr. Stoltzfus stated he will have workers bring rendering/skins/intestines to the compost pile regularly throughout the day so as to prevent odors from occurring. He stated that bones and heads will not be added to the compost pile, they will be kept in a cooler and then disposed of with their regular trash. Mr. Stoltzfus stated they are still land applying blood water to the field in the back right of the property for now until they plant crops in the beginning of June. It was sunny and 59°F, and winds were SE at 5 mph at the time of inspection.

Investigation Description: On May 8, 2024, I, Jonathan Bower, Solid Waste Supervisor and Bedhr Majeed, Environmental Trainee conducted an inspection at Kingdom Provisions (KP). On this day the weather was partially cloudy and approximately 75 degrees at the time of the inspection. Early that morning there was heavy rain of approximately ¾ of an inch in a short, passing system. This inspection was also conducted in response to complaints of offsite odors, filed with the Department on Monday, May 6, 2024, as well as later in the day after completion of the inspection on, Wednesday, May 8, 2024.

Upon arriving on site, a slight odor of manure was observed at the front of the property. We proceeded to the rear of the building, located on site, where butchering operations occur. At the rear of the building we met with Ephraim Stoltzfus, an owner for Kingdom Provisions and Mr. Bauer an equipment operator working for KP.

At the rear of the building there are 2 openings, equipped with small conveyors where the residuals from the butchering process exit the building. At previous inspections containers intended for offsite rendering were placed at this location to collect the food processing residuals (FPR). The containers were then stored in the adjacent parking area, awaiting removal. At the time of this inspection a loader and its bucket were being used to collect the FPR material, then the loader was transporting the FPR material to the composting area in a field separated by a short stone roadway. At this time, we also discussed washing containers and equipment inside where the wash water can be contained and not impact storm water.

The site walk continued back to the composting area. The composting area consisted of a windrow approximately 100 feet in length, 8 feet in width and 4 feet in height. Ephraim explained that the area had been regraded and a pad consisting of woodchips was constructed. Ephraim explained how FPR material is applied, cover and turned. He also explained that no FPR material containing bones is added to the compost pile. This is done to help reduce the time frame for the biological process of composting to be completed. The FPR material that does contain bones is still containerized and shipped off site for further processing. He also stated that two windrows the size of the one present would be needed.

In this area odors were observed to be strong when close to the section where animals remains were actively being added, from the butchering process to the compost pile. The odors decrease as we traveled the length of the compost pile to the older and turned material. Odors similar to the odors observed in this area were not detected at the building where we met, nor in the walk back to the compost area. There was standing water in areas around the compost which were likely due to the rain that morning.

Investigation Description: On May 30, 2024, I, Bedhr Salam Majeed, Environmental Trainee and Kirsti Kraus WM Environmental Protection Specialist, conducted an inspection at Kingdom Provisions (KP). Weather during inspection was 71; partly cloudy with winds 4mph NW:10mph gusts. This inspection was also conducted in response to complaints of offsite odors, filed with the Department on Monday May 17, 2024, Tuesday May 21, 2024; Wednesday May 22, 2024; Thursday May 23, 2024; and Friday May 24, 2024.

Prior to arriving on site, the surrounding area was surveyed for odors. This was done by driving from East and West on Durham Road.. A slight manure odor was detected offsite on the West side of the site between 6030 Durham Road and Kingdom Provisions property. We proceeded to the rear of the building, located on site, where butchering operations occur. At the rear of the building, we met with Samir Hammed (Manager) and Carly Seldow of Bucks County Conservation Department (BCCD).

At the rear of the building there are 2 chutes, equipped with small conveyors where the residuals from the butchering process exit the building. During previous inspections containers intended for offsite rendering were placed at this location to collect the food processing residual (FPR). The containers were then stored in the adjacent parking area awaiting removal. At the time of this inspection a loader and its bucket were being used to collect the FPR material, the loader would then transport the FPR material to the composting pile in a field separated by a short stone roadway. A recent pickup of offsite renderings was done on 5/28/2024. Upon arriving at the South side of the site, Samir showed us a new practice of an inside wash area for containers and equipment where all wash water runoff would be contained. Samir stated that the wash water pit would be pumped every four to five (4-5) days by Nicholas Septic. Records of disposal from Nicholas Septic were asked to be sent electronically via the emails provided to Kingdom Provisions from myself and Kirsti.

The site walk continued back to the composting area. The roadway to the windrow piles was free of animal remains. The composting area consisted of two (2) windrow compost piles approximately 50 feet in length, 8 feet in width and 4 feet in height. Pile #1 appeared to have been managed, by turning material and providing cover in a way that this pile was sufficiently producing a compost material. On Pile #2 a recent pile of Cow Stomachs and Heads were visible without being covered with woodchips. Samir stated woodchips from Haycock Farms would be received later that day and applied to the pile. Samir agreed to send an Email later that day with pictures confirming the woodchip placement on the windrow piles. A picture sent by Samir is titled image 5 on page 7.

In the compost area odors were observed to be a mild decomposing odor near the animal remains actively being added to compost pile #2. The odors would decrease as we traveled the width of the compost pile to the older and turned material in pile #1. Odors like the odors observed in the compost area were not detected at the North or South side of the building, nor in the walk back to and from the compost area. The odors observed in the compost area were not observed in the compost area were not observed in the time of this inspection.

Upon leaving the site weather conditions were 72¿, Partly Cloudy with winds 4mph NW: 6mph gusts. Kingdom Provisions has agreed to submit a plan in June of 2024 addressing the best management practices for the management of FPR as compost as well as a land application system (LAS). Comments have been provided by the Department to KP addressing the manure management plan previously submitted, addressing the LAS of FPR. As of the date of this report the Department has not received additional information about BMP from KP.
